## I Need Childcare Services on a Daily Basis!

### Licensed Nursery Schools (Municipal/Private)

Children from fifty-eight days old, including the day of birth, up to preschool age (as of April 1 of the fiscal year you use the service. Requirements vary depending on the facility you use.)

#### Childcare fee

Decided according to the parents/guardians' resident's tax (Nerima City income tax amount)

\* No childcare fee for the second child onwards, for children in the three-year-old class or above, and for children in the zero to two-year-old class from households exempted from resident's tax.

### Family-Style Childcare Program (Hoiku Mama)

A family-style childcare provider (Hoiku Mama) with nursery school or other qualifications takes care of three to five children in a family-style atmosphere, such as a home.

#### Eligibility

Children from fifty-eight days old, including the day of birth, up to two years of age.

Children who need childcare because of their parents/guardians' employment, etc.

#### Childcare fee

Decided according to the parents/guardians' resident's tax (Nerima City income tax amount)

\* No childcare fee for the second child onwards and for children in the zero to two-year-old class from households exempted from resident's tax.

### Small-Scale Childcare Program

Enrollment Consultation Subsection,

This is a small-scale childcare facility with a capacity of up to nineteen children. The licensing standards vary between the three types of facility: A, B and C.

#### Eligibility

Children from fifty-eight days old, including the day of birth, up to two years of age.

Varies by facility.

Children who need childcare because of their parents/guardians' employment, etc.

#### Childcare fee

Decided according to the parents/guardians' resident's tax (Nerima City income tax amount)

### Nurseries within Companies

Enrollment Consultation Subsection,

Childcare is provided at a facility within a company office for children of office employees as well as local children in need of childcare.

#### Eligibility

Children from fifty-eight days old, including the day of birth, up to two years of age.

Varies by facility.

Children who need childcare because of their parents/guardians' employment, etc.

Decided according to the parents/guardians' resident's tax (Nerima City income tax amount)

## Home Visit-Type Childcare Programs

Enrollment Consultation Subsection,

At-home, visit-based childcare providers are dispatched to the residences of children to provide one-on-one childcare. There are two types of programs: one is for children with disabilities who require medical care due to disability or illness and have significant difficulty in group childcare, and the other is for children without disabilities who want home visit-type childcare.

### Eligibility

Children from fifty-eight days old, including the day of birth, up to preschool age (as of April 1 of the fiscal year you use the service)

Children who need childcare because of their parents/guardians' employment, etc.

### Childcare fee

Decided according to the parents/guardians' resident's tax (Nerima City income tax amount)

\* No childcare fee for the second child onwards, for children in the three-year-old class or above, and for children in the zero to two-year-old class from households exempted from resident's tax.

## Licensed Day Nurseries

Any licensed day nursery

These are private childcare facilities licensed by the Tokyo Metropolitan Government for meeting independent standards, and Nerima City subsidizes their operation. Please call the facility you want to use directly for more details on use and information on application procedures.

### Eligibility

From newborns on up. Requirements vary depending on the facility you use.

### Childcare fee

Varies depending on the facility. For more information, please call the facility you wish to use directly.

\* For up to 220 hours of childcare per month for children under three years of age, the monthly fee is a maximum of ¥104,000. For children three years of age or older, the maximum is ¥101,000.

## Free Childcare at Unlicensed Childcare Facilities and Childcare Fee Subsidies

Childcare Services Promotion Subsection,  
Day Nursery Management Section

Tax-exempted households with children up to two years old and all households with children three years old and older are eligible for free childcare when an unlicensed childcare facility is used, provided that the need for childcare is certified and the facility has received a "confirmation" from the local municipality.

In addition, subsidies will be provided to guardians of children with a residence in Nerima City who have a monthly contract for 160 hours or more of usage per month with an unlicensed childcare facility (whether inside or outside of Nerima City) that has received a certificate from the Tokyo Metropolitan Government stating that they meet guidance and supervision standards. This subsidy is not available when a contract is signed in the middle of the month (enrollment as of the first day of each month is a requirement).

Applications should be made through the facility within 30 days of start of use. In principle, the subsidy will not be issued retroactively.

### Maximum subsidy amount (per month)

Child 0-2 years old, tax-exempted household  
Free up to ¥42,000 + childcare fee subsidy of ¥25,000

Child 0-2 years old, taxed household  
Childcare fee subsidy  
First child: ¥40,000

Second child onwards: ¥67,000

Child 3 years old and up, all households  
Free up to ¥37,000 + childcare fee subsidy of ¥20,000

- \* Child ages are based on their full age as of April 1 each year.
- \* The subsidy will cover a portion of the childcare fees up to the maximum amounts above.
- \* Childcare fees do not include meal expenses, bus fare, etc.

## Municipal Kindergartens

There are three municipal kindergartens in Nerima City. Two-year childcare is offered for children between four and five years of age living in the city. Children who need special consideration—such as those whose mental or physical development is slow (but can do almost everything themselves)—can also be admitted. The recruiting schedule is announced sometime in September in the *Nerima News*. Please apply directly to the kindergarten you would like your child to attend, including instances in which you want to enroll your child in the middle of the fiscal year.

### Eligibility

Children between four and five years of age living in Nerima City

**Childcare fee** Free of charge

## Licensed Kodomoen

### Any Licensed kodomoen

A licensed kodomoen is a facility that provides comprehensive preschool education and childcare, such as a kindergarten or nursery school, as well as childrearing support in the community. In addition, subsidies from Nerima City are available to cover a portion of the entrance fees and childcare fees. After enrollment, please check with the licensed kodomoen and apply to receive the subsidy.

Children between three and five years of age

After enrolling, please check with your kindergarten and apply for the subsidy.

## Nerima Kodomoen

Children's Policy Subsection, Children's Policy Planning Section

As part of Nerima City's independent program, private kindergartens (including licensed kodomoen) that offer long-hour childcare throughout the year (including summer, winter, and spring vacations) are authorized to operate as Nerima Kodomoen.

Nerima Kodomoen offers daycare for eleven hours (standard daycare), daycare for nine hours or more (shortened hour daycare), and daycare for zero to two-year-olds (young age daycare), expanding the choices of children's education and childcare for families with working parents/guardians and others.

### Eligibility

Children under three years old in need of childcare  
Children between three and five years of age who need childcare

## I Need Childcare on a Temporary Basis!

### Family Support Program

Childcare on a One-to-One Basis

Nerima Family Support Center ☎3993-4100

People in the community who complete the training that Nerima City conducts are paid volunteers (supporting members) qualified to provide childcare on a one-to-one basis. Childcare is provided at either the home of an aid-providing member, the home of a user member, or a Fami Suppo Home (a room in a Public Health Center in six locations in Nerima City). Registration as a user member is required to use the program.

\* To register, you must fill out a membership enrollment/application form, which you can download from the Nerima City website.

**Eligibility** Nerima City residents with a child between fifty-eight days old and the sixth grade of elementary school

**Hours** 7 a.m. to 8 p.m.

**Fee** Weekdays, ¥800 per hour; Saturdays, Sundays, national holidays and ¥900 per hour during the year-end/New Year's holidays

### Temporary Childcare for Infants and Toddlers

Childrearing Support Subsection, Home Childrearing Support Section ☎5984-5673

Childcare is provided regardless of the reason, such as when the parent/guardian simply wants to relax. To use this service, you must first visit the facility to complete an interview and registration procedures (reservation required), then please apply no later than 3 p.m. the day before the desired day of use (same-day reception is also possible).

\* You will need a usage registration application form and the usage slip to register. You can download these forms from the Nerima City website.

**Eligibility** Children six months old to preschool age

**Fee** Newborns up to one year old: ¥2,000 per three-hour unit  
One year old or older: ¥1,500 per three-hour unit

**Eligibility** Children with disabilities between one year and six months and twelve years of age (grade six), children who have development concerns

**Days and hours** Mon. to Sat. 9 a.m. to 5 p.m. (excluding national holidays and the year-end/New Year's holidays)

### Short-Term Special Case Childcare

Childcare When a Parent/Guardian Is Ill or Giving Birth

If a child living in Nerima City who is usually cared for at home needs childcare for reasons such as the parent/guardian is giving birth or is hospitalized or the illness of a family member, this program provides temporary childcare by a childcare worker or at some childcare facilities with vacancies. For more information, please ask the Childcare Services Subsection of the Day Nursery Management Section.

### Temporary Childcare at Nursery Schools

Group Childcare

Any temporary childcare facility

Childcare is provided in a special childcare room within nursery schools when parents/guardians require temporary childcare for reasons such as eliminating childrearing exhaustion or in cases of childbirth or sudden illness. Children living in Nerima City between the ages of fifty-eight days including the day of birth (varies by nursery school) and preschool age that can adjust to group childcare are eligible. Please note that children who commute to a licensed day nursery cannot use this service. Depending on the availability of your desired date of use, facilities may be unable to accept your child on the days, hours, or at the eligible ages listed below. For details, please contact a nursery school that offers this service.

## Short Stay for Children

When Providing Childcare at Home is Difficult

Childrearing Support Subsection,  
Home Childrearing Support Section ☎5984-5673

Overnight childcare is provided when it is difficult for a parent/guardian to provide care at home due to illness, hospitalization for childbirth, or work, etc. To use this service, you must first complete an interview and registration procedures (reservation required), then apply three days before (excluding Saturdays, Sundays, and national holidays) the desired date of use.

Pick-up and drop-off services to/from nursery schools and other childcare facilities are available (for a fee; service not available at the Home for Infants and Toddlers). Daycare use without an overnight stay is also possible at the Home for Infants and Toddlers.

**Eligibility** Children living in Nerima City who can adjust to group living

**Fee** ● Families registered with Hidamari-so and Tokyo Metropolitan Shakujii

One-night, two-day stay: ¥6,000 (an additional ¥3,000 for each day afterward)

● Saint Odilia Home for Infants and Toddlers

Daytime (under 9 hours): ¥1,500

One night, two days (under 24 hours): ¥2,500

\* Households exempted from resident's tax, households receiving public financial assistance for everyday living, and multiple birth households can apply for fee reduction or exemption.

### Required items and documents

1. Photos: A recent photo of the child and one of the person who will pick up the child, such as a parent/ guardian. A photo with the child and parent/ guardian together is also acceptable.
2. *Mother and Child Health Handbook*
3. Documentation with your address on it (such as a copy of your health insurance card)
4. Documentation showing the reason for the stay
5. Certification for households exempted from resident's tax or households receiving public financial assistance for everyday living

## Twilight Stay for Children

When a Parent/Guardian Has to Work Overtime

Childrearing Support Subsection,  
Home Childrearing Support Section ☎5984-5673

Childcare is provided between 5 p.m. and 10 p.m. when it is difficult for care to be provided at home, such as when a parent/guardian is unable to pick up the child from nursery school on time due to a business trip or having to work overtime. To use this service, you must first complete an interview and registration procedures (reservation required), then apply three days before (at Piyo-Piyo, this excludes Sundays and national holidays; at Tokyo Metropolitan Shakujii Gakuen, this excludes Saturdays, Sundays, and national holidays) the desired date of use. Pick-up and drop-off services to/from nursery schools and other childcare facilities are available (for a fee).

**Eligibility** Children living in Nerima City who can adjust to group living

**Fee** ¥2,000 each time

\* Households exempted from resident's tax, households receiving public financial assistance for everyday living, and multiple birth households can apply for fee reduction or exemption.

### Required items and documents

1. Photos: A recent photo of the child and one of the person who will pick up the child, such as a parent/ guardian. A photo with the child and parent/ guardian together is also acceptable.
2. Documentation with your address on it (such as a copy of your health insurance card)
3. Documentation showing the reason for the stay
4. Certification for households exempted from resident's tax or households receiving public financial assistance for everyday living

When a Child Is Ill or Recovering from Illness

## Childcare for Children Who Are Ill or Recovering from Illness

Any facility that offers childcare for children who are ill or recovering from illness

Temporary childcare is provided for children who attend nursery school, etc., who are in the "post-illness recovery period"\* when group childcare is difficult, or who have not yet reached the post-illness recovery period but are otherwise in stable condition.

\* The term "post-illness recovery period" refers to:

- After the child is examined by a doctor and found to have passed the acute stage
- In the case of an epidemic, after the child passed the infection period
- For an injury, after the child's condition has stabilized

### Eligibility

Children between six months and nine years of age who fall under either of the following:

- (1) Children who live in Nerima City and commute to a nursery school, etc.
- (2) Children who commute to a nursery school, etc. in Nerima City

### Fee

Registration fee: ¥1,000 per facility (Registration is valid until ten years of age)

Childcare fee: ¥2,000 per day; a separate fee is charged for meals

\* You may be able to apply for a reduction or exemption depending on your household's tax situation

### Days

For all facilities, Monday through Friday (excluding national holidays and the year-end /New Year's holidays)

### Usage procedures
